Solicitor Adrian Mueller's predictive behaviour, contempt of court, falsified documents, and insurance claims in two CTTT/NCAT cases in 2012/2013 (SCS 12/32675 and SCS 12/50460, conducted by Tribunal member M. Harrowell) and 2020 (SC 20/33352, conducted by Tribunal member G.J. Sarginson)

Applicant – Lot 158 of strata plan SP52948 Respondent – Owners corporation SP52948

Solicitor Adrian Mueller created dangerous precedence in two CTTT/NCAT cases (SCS 12/32675 and SC 20/33352) which, based on Australian legal system, allow other parties to use as valid defence:

- 1) Coerce Tribunal he was legal representative of Respondent without offering evidence of valid procedure for his Standard Costs Agreement or legally-compliant meetings of Respondent,
- 2) Suggest to Respondent use of insurance claims for his legal costs,
- 3) Send secret defamation threats to Applicant before two Tribunal Hearings as an attempt of intimidation and deterrent,
- 4) Prevent Applicant's Motion for Annual General Meetings,
- 5) Had direct knowledge of Applicant being denied to access strata documents, in spite of paid document searches and evidence of being legal member of the committee.
- 6) Not comply with Tribunal orders at Directions Hearings to submit evidence of behalf of Respondent (Solicitor Adrian Mueller failed to comply with Tribunal orders six times whilst not authorised to represent owners corporation in period 2012 to 2021),
- 7) Prevent Respondent from attending Hearings and coercing Tribunal to ignore Applicant's evidence due to Respondent's absence,
- 8) Actively support threats (even death threats) to Applicant, without taking actions to prevent such behaviour,
- 9) Bring no evidence at Hearings and deny/refute all Applicant's statements (without offering any files to counter their claims),
- 10) Co-operate with Respondent to submit false insurance claims for his legal costs (four claims) in CTTT SCS 12/32567 in GST exclusive amount of \$24,919.31 in 2012/2013 and undisclosed insurance claim in NCAT case SC 20/33352 in GST exclusive amount of \$19,758.14 in March 2022,
- 11) Directly responsible for preparing falsified evidence in Statutory Declaration for CTTT on behalf of BCS Strata Management Peter Bone on 19 April 2013, and had full knowledge of false statements by Peter Bone in Affidavit to District Court case 2013/360456 on 31 January 2014, and not providing any evidence in Affidavit by Solicitor's receptionist for case SC 20/33352 dated 8 February 2022,
- 12) Coerce Tribunal to enforce costs recovery from Applicant without approval of SP52948 at any legally-convened meeting, whilst being accessory to insurance claims as back-up option for his legal costs,
- 13) Attempt to justify non-compliant committee meetings dated 8 July 2012, 19 April 2013 (scheduled for 26 March 2013 and brought forward as time-warped event), and all meetings in 2020, 2021, and 2022 (CTTT dismissed Solicitor's claims and declared meetings 8 July 2012 and 19 April 2013 ineffective in their decision in SCS 12/32675 on 6 November 2013),
- 14) Prevent Police, CTTT/NCAT, Fair Trading NSW, Office of Legal Services Commissioner, District Court, and Supreme Court from access to Respondent's files and his alleged correspondence with Respondent.

Extract from Applicant's 116-page submission to Solicitor Adrian Mueller on 27 February 2022 which Solicitor ignored

Current Office of Legal Services Commissioner (OLSC) case CAS006791 and pending submission in person for Crime Stoppers Event 648467: Solicitor Adrian Mueller: professional misconduct, involvement in fraud, falsified evidence and false representation in CTTT cases SCS 12/32675, SCS 12/50460, SCS 13/50737, NCAT case SC 20/33352, false representation in District Court case 13/360456, refusal to co-operate with OLSC in three previous submissions (41368, 56561, CAS005901), persistent contempt of court through willful disobedience to, and disregard of, court orders and misconduct in the presence of courts and Tribunals (in period 2012 to 2021, Solicitor Adrian Mueller failed to comply with CTTT/NCAT orders for the Hearings six times), refusal to co-operate with Police Event E65804633 and NCAT in case SC 20/33352 by withholding evidence and coercing the Tribunal to ignore evidence of the Applicants without considering it, earnings through proceeds of crime (insurance fraud), and serial litigator with intention to harass (including being silent witness of stalking, exposure to ridicule, discrimination on religious and nationality basis, being aware of anonymous death threats against Applicant and not taking any action to prevent such actions, and more), waste court time, and incur expenses for personal benefits. Solicitor Adrian Mueller not only initiated an abuse of the court processes to gain personal advantage through proceeds of crime but caused harm to other parties (to harass and annoy, to cause delay and detriment).

Actions by Solicitor Adrian Mueller obstructed Police investigators, insurance investigators, and other government officials (Fair Trading NSW, CTTT/NCAT, OLSC) and perverted the course of justice, falsified evidence, provided statements knowing they were not factual, earned income through proceeds of crime, and more).

Solicitor Adrian Mueller was recipient of formal request "20220209-Re_OLSC case CAS005901 - Request for Solicitor Adrian Mueller to respond with evidence on 8Feb2022-1750.pdf", as sent by Applicant on 8 February 2022. No reply was received for OLSC or Applicant. Substance of Conduct Matter for Solicitor Adrian Mueller:

- 1. Breach of section 172 LPUL (NSW) legal costs must be fair and reasonable,
- 2. Breach of section 178 LPUL (NSW) non-compliance with disclosure obligations,
- 3. Breach of section 180 LPUL (NSW) making costs agreements,
- 4. Breach of section 185 LPUL (NSW) certain costs agreements are void,
- 5. Misappropriation, caused deficiency in owners corporation SP52948 funds and insurance company's funds,
- 6. Failure to comply with a requirement under section 371 LPUL (NSW) and failure to assist an investigator in the investigation of a complaint,
- 7. Breach of section 387 LPUL (NSW) obstruction of investigator,
- 8. Breach of section 388 LPUL (NSW) obligation of lawyers,
- 9. Breach of sections 3, 4, 5, 6, 7, 12, and 14 of Legal Profession Uniform Law Australian Solicitors' Conduct Rules 2015 under the LPUL.

False statements are a very serious offence in their own right. Deliberate lying in a Statutory Declaration is punishable by up to five years in prison, according to the NSW Oaths Act. Former judge Marcus Einfeld served two years in prison for knowingly making a false statement under oath and for attempting to pervert the course of justice. The case stemmed from the improbable catalyst of a false statutory declaration over a \$77.00 speeding fine.

Solicitor Adrian Mueller is prepared to go take extreme steps to protect own interests, which include examples from 2017, 2018, 2019, 2020, 2021, and 2022:

Example of Solicitor Adrian Mueller directly preventing Applicant's Motion at Annual General Meeting 2017

Motion: Confirm undisclosed insurance claims for Lot 3 in 2012/2013 with evidence of illegal activities

The Owners Corporation SP52948 by ORDINARY RESOLUTION, confirms the following:

- BCS Strata Management and EC members failed to include this Motion in the agenda for AGM 2016 without due notice to the requestor of the Motion, and owners corporation denied a vote on the Motion.
- BCS Strata Management, with full knowledge and support by EC members, made four insurance claims in amount of \$24,919.31 for alleged "defense" of Lot 3 at CTTT in 2012/2013;

First claim on 31st of August 2012 \$367.64 Second claim on 7th of December 2012 \$12,714.65 Third claim on 26th of April 2013 \$1,320.00 Fourth claim on 4th of June 2013 \$10.517.02

- BCS Strata Management and EC members failed to disclose the insurance claims in any financial statements to owners corporation.
- The insurance policy was changed one month before the secret first claim was made, in spite of insurance broker's warnings about high risks,
- . Owner of Lot 3 was ex-Chairperson of the Executive Committee and current member,
- Solicitor Mr. Adrian Mueller, who recommended the insurance claims in 2012, reviewed this Motion on, or around 5th of September 2016.
- . The legal case for defense of Lot 3 did not exist.
- At EC meeting held on 16th of March 2017, current EC member Mrs. Lorna Zelenzuk (Secretary of the EC) failed to declare the special interest in issue of insurance reimbursement claim by CHU Insurance at meeting held on 16 March 2017.

A member of the strata committee must disclose any direct or indirect financial interest the member has in a matter to be considered by the strata committee where that interest appears to raise a conflict with the member's duties (SSMA 2015 Clause 18(1) of Schedule 2). The member must not be present during the deliberation of the matter or take part in a decision, unless the strata committee otherwise determines (SSMA 2015 Clause 18(4) of Schedule 2).

- BCS Strata Management secretly changed insurance policy for the complex on 1st of August 2012, without owners corporation approval at any meeting. They started making claims for legal fees for non-existent CTTT case "defending Lot 3", engaging Solicitor Mr. Adrian Mueller (without valid owners corporation decision).
- BCS Strata Management secretly transferred \$50,000.00 into strata funds from MBL account due to lack of money to pay any bills for SP52948 on 4th of July 2012.
- Secret EC meeting (CTTT confirmed it was not compliant with strata laws in 2013) was held in Lot 181 (Mr. Stan Pogorelsky who was unfinancial to represent SP52948 as EC member) without notifying owners corporation on 9th of July 2012. Two other EC members were unfinancial due to undeclared personal benefits from common funds one of them being current EC member Mr. Moses Levitt.
- BCS Strata Management, without approval of the EC or owners corporation at any meeting, changed insurance policy for SP52948 on 1st of August 2012.
- Undisclosed to owners, CTTT, and District Court in 2012, 2013, and 2014. BCS Strata Management signed insurance claim form and provided files on 28th of August 2012.
- First of four insurance claims for non-existent "CTTT Defence of Lot 3" by BCS Strata Management on behalf of Strata Plan 52948 was sent on 31st of August 2012, less than a month after secret change of the insurance policy.
- Solicitor Mr. Adrian Mueller admitted to CTTT that Lot 3 is not part of the proceedings on 26th of October 2012.
- BCS Strata Management issues second insurance claim for non-existent "CTTT Defence of Lot 3" in amount of \$12,714.65 on 7th of December 2012.

- Solicitor Mr. Adrian Mueller initiated CTTT case for alleged losses to SP52948 three days later on 10th of December 2012 without approval or knowledge of owners corporation.
- Three different Standard Costs Agreements with Solicitor Mr. Adrian Mueller were uncovered by Lot 158 by June 2017, of which two have strong evidence of being created through falsified documents with intention to obtain personal benefits and hinder investigations.
- McCulloch Lawyers, on behalf of CHU Insurance, requested owners corporation to repay \$8,800.00 for insurance claims that BCS Strata Management had made.

BCS Strata Management was aware of this at least since 19th of October 2016 and kept owners corporation uninformed until they left.

Waratah Strata Management, Mr. Robert Crosbie, was aware of this since 11th of January 2017.

- Waratah Strata Management and EC members failed to disclose full information about insurance claims to owners corporation.
- Mr. Stan Pogorelsky, fully supported by EC members, tried to bully and prevent Lot 158 from passing evidence to CHU Insurance on 3rd of April 2017.

- Two reports by the Office of Legal Services Commissioner, dated 31st of May 2013 and 13th of June 2013 were not disclosed by BCS Strata Management and EC members to owners corporation,
- Alternative quotes from other legal services providers were never disclosed and evidence of their existence not shown at any meeting.

Motion: Confirm payment to Solicitor Mr. Adrian Mueller for undisclosed service on 5th of September 2016

The Owners Corporation SP52948 by GENERAL RESOLUTION (A ONE LOT/ONE VOTE FORMAT), confirms the following:

- Solicitor Mr. Adrian Mueller was engaged on, or around, 5th of September 2016 without disclosure of
 expenses in any financial statement given to owners corporation at general meeting.
- Solicitor Mr. Adrian Mueller was paid \$1,100.00 (GST included) for reviewing 50 pages of Motions submitted by Lot 158,
- BCS Strata Management and EC members failed to provide Costs Disclosure to owners corporation,
- Solicitor Mr. Adrian Mueller reviewed and provided advice on Motions submitted by Lot 158, with end
 result of 34 Motions being entirely excluded from agenda of the general meeting without due notice to the
 requestor and owners corporation denied a vote on the motions, and 6 Motions not including Explanatory
 Notes of crucial importance for owners corporation to have full knowledge of material circumstances
 before voting on 19th of October 2016,
- Alternative quotes from other legal services providers were not disclosed and evidence of their existence not shown at any meeting.

Example of Solicitor Adrian Mueller directly preventing Applicant's Motion at Annual General Meeting 2018

Motion: Order strata documents to be handed over by Solicitor Mr. Adrian Mueller

The Owners Corporation SP52948 by ORDINARY RESOLUTION confirms and approves the following:

- Section 192E of the Crimes Act 1900 states that a person who, by any deception, dishonestly obtains property
 belonging to another, or obtains any financial advantage or causes any financial disadvantage, is guilty of the offence
 of fraud, with maximum penalty of imprisonment for 10 years.
- Section 316 of the Crimes Act 1900 (NSW) makes the knowing concealment of information relating to a "serious indictable offence" a crime punishable by up to 2 years imprisonment.

Section 4 of that Act defines "serious indictable offence" to mean an indictable offence that is punishable by imprisonment for life or for a term of 5 years or more. Subject to certain exclusions this generally includes the fraud offences in Part 4AA of that Act as well as stealing and similar offences in Part 4.

Section 316(1) states if a person has committed a serious indictable offence and another person who knows or believes that the offence has been committed and that he or she has information which might be of material assistance in securing the apprehension of the offender or the prosecution or conviction of the offender for it fails without reasonable excuse to bring that information to the attention of a member of the Police Force or other appropriate authority, that other person is liable to imprisonment for 2 years.

- There is currently no maximum elapsed time period for indictable offences in NSW.
- After owners corporation was forced to repay \$8,800.00 to CHU Insurance for insurance claims in first quarter of 2017 for events that occurred in 2012/2013, Fraud Report E65804633 dated 9th September 2017 was submitted, with Police investigations and interviews starting in late 2017 and continuing in 2018.

Issues in the investigations include alleged false statements by BCS Strata Management in Statutory Declaration to CTTT on 19th April 2013, four different versions of the same Standard Costs Agreement with Solicitor Mr. Adrian Mueller, secret change of the insurance policy for SP52948 and then claiming amount of \$24,919.31 (plus GST) for alleged "defense" of Lot 3 at CTTT in 2012/2013 without owners corporation full disclosure or decision at any general meting, false written statements to CTTT by selective EC members, invoice paid for insurance premiums to Gallagher Australia on 21st September 2012 in amount of \$84,414.77, which was 74.38% higher than in September 2011, losses to Lot 158 in amount of close to \$29,000.00.

Solicitor Mr. Adrian Mueller, was actively involved in the creation of the Statutory Declaration, against the wishes of owners corporation or approval at any general meeting or disclosure, caused excessive courier costs to owners corporation in amount of \$851.56 on 19th April 2013 and was based on rushed EC meeting seven days ahead of scheduled date, without owners being able to respond, comment, or complain.

 Secretary of the EC Mrs. Lorna Zelenzuk and acting Chairperson Mr. Robert Crosbie failed to include Motion at AGM 2017 confirm payments to Solicitor Mr. Adrian Mueller, in non-compliance with Strata Schemes Management Act 2015, Schedule 1, c(4):

Solicitor Mr. Adrian Mueller was engaged 14 times in period March 2012 and September 2016 without disclosure of expenses in any financial statement given to owners corporation at general meetings,

Solicitor Mr. Adrian Mueller was paid \$63,318.77 (GST included), with full details for 2017 and 2018 undisclosed to owners by Waratah Strata Management:

Mr. Adrian Mueller was allegedly engaged to provide legal advice at an estimated cost of \$3,500.00 + GST and review Lot 158 owner's motions for AGM 2017 at an estimated cost of \$1,750.00 + GST (documented in the Minutes of EC meeting on 20th July 2017).

- For missing documents that are critical to proving false statements by BCS Strata Management staff in Statutory Declaration to CTTT on 19th Aril 2013, Police requested access to strata files from BCS Strata Management and Solicitor Mr. Adrian Mueller (separate Motion for AGM 2018 deals with Waratah Strata Management).
- Based on latest update from the Police dated 22nd August 2018, none of the parties provided copies of eight emails, with statement that Mr. Adrian Mueller attempted to find them but failed to locate them.
- Legal Profession Uniform Law Australian Solicitors' Conduct Rules 2015, under the Legal Profession Uniform Law, the following applies to legal profession:
 - 4.1 A solicitor with designated responsibility for a client's matter, must ensure that, upon completion or termination of the law practice's engagement:

14.1.1

the client or former client, or

14.1.2

another person authorised by the client or former client, is given any client documents, (or if they are electronic documents copies of those documents), as soon as reasonably possible when requested to do so by the client, unless there is an effective lien.

- 14.2 A solicitor or law practice may destroy client documents after a period of 7 years has elapsed since the completion or termination of the engagement, except where there are client instructions or legislation to the contrary.
- As 7-year period expires in February 2021 (from the completion of the law practice engagement in 2014), owners
 corporation issues an order to Solicitor Mr. Adrian Mueller to give all SP52948 documents to current Secretary of the
 Executive Committee at no cost, who shall ensure that Police receives the copies of missing eight emails.
- If Solicitor Mr. Adrian Mueller fails to comply, owners corporation shall raise a complaint with the Office of the Legal Services Commissioner (OLSC), which already had a caution against Mr. Adrian Mueller for not following legal practices in SP52948 in 2013, and raise a further complaint with the Department of Fair Trading.

Example of Solicitor Adrian Mueller directly preventing Applicant's Motion at Annual General Meeting 2018

Motion: Order to Waratah Strata Management to produce eight copies of emails to Police and Lot 158

The Owners Corporation SP52948 by ORDINARY RESOLUTION confirms and approves the following:

 Fraud Report E65804633 dated 9th September 2017 initiated Police investigations and interviews in late 2017 and during 2018.

For missing documents that are critical to proving false statements by BCS Strata Management staff in Statutory Declaration to CTTT on 19th Aril 2013, Police requested access to strata files from Waratah Strata Management Mr. Robert Crosbie.

Waratah Strata Management provided incomplete strata files and none of the eight crucial documents (copies of emails) were included.

 Two written reports from BCS Strata Management claim that all SP52948 were provided to Waratah Strata Management before end of their contract on 30th January 2017:

Representative of Pica Group (parent company of BCS Strata Management) in email on 13th February 2018.

BCS Strata Management Licensee-in-Charge Dr. Adrian Carr in email on 20th July 2018.

- Strata Schemes Management Act 2015, Section 180 prescribes that certain records of strata plan must be retained for period of seven years, and that includes all correspondence and emails.
- In accordance with Strata Schemes Management Act 2015, Section 181, owners corporation issues a request to Waratah Strata Management to produce eight emails no later than 14 days after the notice. The emails shall then be handed over to the Police.
- Owners corporation shall hand over copies of eight missing emails (and other strata documents as listed for the members of the EC and Waratah Strata Management) that lot 158 did not get in spite of paid document search on 13th June 2017.
- Owners corporation acknowledges that refusal to provide the documents might incur additional costs at owners expense and force NCAT Tribunal's orders.

SP52948 financial discrepancies from when Waratah Strata Management took office on 1 February 2017 to 29 April 2022, with emphasis on last three Annual General Meetings (AGM)

31/01/2017 changeover from BCS Strata Management to Waratah Strata Management: Balance Sheet had positive balance in amount of \$129,704.57

17/10/2019 day of AGM: Balance Sheet had negative balance in amount of \$131,852.25

22/10/2020 day of AGM: Balance Sheet had positive balance of only \$14,411.82


31/10/2020 nine days after AGM: Balance Sheet had positive balance of only \$8,368.92

28/10/2021 day of AGM: Balance Sheet had positive balance of only \$1,019.14

Six versions of Solicitor Adrian Mueller's alleged costs in NCAT case SC 20/33352

Cost figures (GST excl) provided by Solicitor Adrian Mueller on 12 July 2021, 7 February 2022 (no invoices were included by the Solicitor), and 25 March 2022, and listed on Waratah Strata Manager's agenda for Annual General Meeting on 7 October 2021 differ to a large extent.

Solicitor Adrian Mueller refused to respond to emails dated 27 February 2022, 5 April 2022, and 20 April 2022 – not only ignoring the Applicant, but Supreme Court Cost Assessor as well. Solicitor Adrian Mueller used silence as his defence, or providing statements that had no evidence. Such actions can bring penalties against lawyers, as Legal Services Commissioner v Yakenian [2019] NSWCATOD [98] proved: a solicitor of Fairfield in western Sydney, neighbour of Cabramatta and Villawood. He was referred to the NSW Legal Services Commissioner by District Court Judge, her Honour Wass DCJ. The defendants' solicitor requested particulars of Mr Yakenian's builder client's statement of claim and said the defendants would provide defences within a reasonable time after the particulars were given. They invited the solicitor to advise them if he had any difficulty with this course. He did not do so. There was also talk of a security for costs application.
