- 3. The costs respondents appear to assert that the solicitor for the costs applicant was not authorised to apply for this costs assessment. But the costs respondents' own documents indicate that a decision was made by the strata committee of the costs applicant at its meeting held on 3 March 2022 to authorise the costs applicant's solicitor to apply for this costs assessment (see page 16 of the costs respondents' letter to the costs assessor dated 31 March 2022).
- 4. The costs respondents also appear to assert that the costs applicant's solicitor was not authorised to represent the costs applicant in the underlying proceedings. The material the costs applicant furnished to the costs assessor on 25 March 2022 included the minutes of the annual general meeting of the costs applicant held on 22 October 2020 at which a resolution (motion 9) was passed to engage the costs applicant's solicitor to act for the costs applicant in the underlying proceedings and that decision was communicated to the solicitor by the costs applicant's strata managing agent by email dated 23 October 2020 (see PDF file entitled "Costs Agreement and Acceptance" sent to the costs assessor on 25 March 2022).

in her four-page submission, accepting statements by Solicitor Adrian Mueller and completely ignoring Lot 158 evidence

- 2. In making the assessment I considered the following documents:

 - ii. Email from JS Mueller & Co for the Applicant dated 25 March 2022;
 - iii. Emails x 5 from the Respondents dated 1 April 2022;
 - iv. Emails x 2 from the Respondents dated 5 April 2022;
 - v. Email from JS Mueller & Co dated 20 April 2022; and
 - vi. Emails x 2 from the Respondents dated 20 April 2022.

In personal email to Lot 158 and Solicitor Adrian Mueller on the same date, Ms. Julie Wright wrote an email pretending not to know the outcome of her decisions and urging "any party" (Lot 158 or Solicitor Adrian Mueller) to pay for her fees:

I have forwarded to the Manager, Costs Assessment, the Certificate of Determination of Costs, Certificate of Determination of Manager's Assessment Costs and Statement of Reasons. The Manager will send out these documents on payment of the costs of the Costs Assessor amounting to \$2,821.50 (inclusive of GST).

It would be prudent to allow a period of fourteen (14) days for the Supreme Court to process the above documentation.
